PLACE OF PROCESSING

All processing will be performed within the European Economic Area (EEA). MODE OF DATA PROCESSING

Data are processed both manually and by computerized modes, in accordance with the purposes heretofore and meeting privacy requirements as well as putting in place all appropriate security measures.

According to article 5 of EU GDPR 679/2016, we also assure you that your personal data shall be

- processed lawfully, fairly and in a transparent manner;
- collected for explicit and legitimate purposes;
- further processed in a manner that is compatible with such purposes;
- adequate, relevant and limited to what is necessary in relation to the purposes for which they are processed; accurate and, where necessary, kept up to date;
- kept in a form that permits identification of data subjects;
- processed in a manner that ensures appropriate security of personal data, including protection against unauthorized or unlawful processing and against accidental loss, destruction or damage, using appropriate technical and organizational measures.

DATA RETENTION PERIOD

- the right to data portability, that is the right to receive all the personal data concerning them and processed by our company in a structured, commonly used and machine-readable format;
- the right to object to the inclusion of all information.

In addition, data subjects shall have the right to lodge a complaint with a regulatory Authority.
